## September Activities

### Field Trips

#### **Second Saturday Bird Walk---September 11 @ 8:00 am**

This open-to-the-public outing will be at Shasta College. Meet in the north parking lot for this ½ day trip. The oak woodlands, wastewater treatment pond, Stillwater Creek riparian, and open fields support a wide variety of species. Bea Currie and Connie Word are the co-leaders.

#### **Local Weekday Bird Walk---Lema Ranch, Tuesday, September 21 @ 8:00 am**

Lema Ranch, an oasis of open space in Redding, is excellent year-around birding. The ponds, orchards, and fields of the McConnell Foundation Headquarters provide an abundance of birds species. We will look for Common Moorhens, rails, migrant passerines, and the resident Merlin. This will be a 2-3 hour walk on paved trails with fine public restrooms. We will meet at the North Parking Lot off Hemmingway Street. Hemmingway Street is across from Mountain View School on Shasta View Drive.

#### **McArthur/Burney Falls State Park---Saturday, September 25 @ 7:30 am**

This park in northeastern Shasta County is famous for its falls and nesting Black Swifts. The swifts will have migrated but the Falls, riparian zone along Dry Burney Creek and Lake Britton should provide a wide variety of birds. Bring a lunch, water, and sturdy shoes. We will rendezvous in the parking lot on the South side of the Redding Convention Center. We should return to Redding in later afternoon. George Horn will lead.

#### ***Turtle Bay's Live Birds of Prey***

Sharon Dale, Curator of Animal Programs along with Amber Davis, Head animal trainer at Turtle Bay will display their live hawks, an owl and a Turkey Vulture. This will be our

chance to see these magnificent raptors up close and to hear stories of their natural history. Ms. Dale has 18 years in this field and was involved in the captive rearing and release program that saved the Bald Eagle. You won't want to miss the stories she has to tell!

### Field Trips

#### **Second Saturday Bird Walk---October 9 @ 8:00 am**

We will return to Turtle Bay and Kutras Lake for the fall and winter seasons. We will assemble in the parking area behind the monolith at Turtle Bay. This walk with Linda Aldrich is open to the public and all skill levels of birders are welcome. A great cross section of waders, raptors, waterfowl, gulls, and winter resident passerines can be seen close up with usually a surprise or two on this half day walk.

#### **Local Weekday Bird Walk---Anderson River Park, Tuesday, October 19 @ 8:00 am**

This gem of riparian habitat has many groomed trails and will be led by Ken Bachman who lives nearby and has a wealth of experience in the Park. We will assemble at the amphitheater in the park for this half-day outing.

A bird walk on the Lema Ranch trails will be held for attendees of the Northern California Audubon Council Meeting. All Wintu Audubon members are invited, also, regardless of whether you wish to attend the meeting (see below).

## Trip Reports

### Hart Ranch, Shasta Valley, May 22

Ten Wintu Audubon Society members traveled to this working cattle ranch in Shasta Valley near Montague in Siskiyou County.



The Hart Ranch folks, friends of Frank and Darliss Sanderson, kindly invited us to explore the birds in this rich habitat. Snow showers in the surrounding mountains and an occasional flurry on us reminded us that this is not our usual spring. Nevertheless, we saw 73 species, counting those seen to and from the Ranch. Probably the most memorable sightings were an immature Golden Eagle being harassed by Black-billed Magpies seen by the Sandersons, Larry Jordan and Michele Swartout and several Virginia Rails called to within 10 feet of us by Michele's tape.

## Rendezvous with Wintu at Lassen

On June 25-27, several RRAS members took the Wintu Audubon chapter up on its invitation to a camp-out at Lassen Volcanic National Park. This is the third year that Wintu has invited neighboring chapters to join it for a weekend of birding. Eureka residents Tom and Sue Leskiw, Jim and Donna Clark, and Chet Ogan joined Garrett and Kerry Watty from Salyer on the outing organized by Bill Oliver. Wintu chapter president George Horn and photographer Larry Jordan also camped out at Lost Creek group



camp (visit [thebirdersreport.com](http://thebirdersreport.com) for photos of birds and other animals seen during the trip).

Several "day trippers" from the Redding area met up with the campers Saturday morning to bird around Manzanita Lake. Ducklings were out in full force, as we observed baby Buffleheads, Wood Ducks, and Mallards cruising with their mothers. Upland brush fields and forest produced species such as Dusky Flycatcher, three kinds of Nuthatch, and a Yellow Warbler singing atop a white fir.

Walks from the campground yielded Pileated and White-headed Woodpeckers and Mountain Bluebird, but Black-backed Woodpecker was a no-show. At the former

Hat Lake (now a creek since the demise of a beaver dam), Clark's Nutcracker, American Dipper, and a large number of Spotted Sandpipers were noted. In between birding forays, we relaxed, conversed, ate, and drank around the campfire.

On Sunday morning, we stopped by PG&E's Lake McCumber to look for birds before returning home, with the highlight there a Common Loon. Bill Oliver compiled a list of 59 species seen by group members during the weekend in Lassen, plus 20 species viewed at Lake McCumber. RRAS should consider a similar outing, inviting our sister inland chapters to join us for some coastal birding.

## Update on the Hatchet Ridge Wind Facility and the Technical Advisory Committee Proceedings

*Wintu Audubon, represented by Conservation Chair Claudia Lyons-Yerion and Rosemary Powder, is currently serving on the Technical Advisory Committee (TAC) for the Hatchet Ridge Wind Facility. The TAC consists of Shasta County Dept. of Resource Management, CA Dept. of Fish and Game, U.S. Fish & Wildlife Service, and the project owner, Pattern Energy. The formation of the TAC was the result of efforts by Wintu Audubon, CDFG and USFWS to ensure oversight as part of the mitigation requirement package to address impacts to birds and bats. The purpose of the TAC is to provide input and guidance on these mitigation requirements.*

The TAC has had two meetings to date, in which the following were accomplished:

- Approval and adoption of the TAC Charter
- A list of consultant candidates was compiled, from which one will be selected to design and perform the Avian and Bat Mortality Study & Monitoring
- Creation a list of objectives to include in the 'Request for Proposals' (RFP) to send to the

consultant candidate for the Mortality Monitoring Study  
Shasta County drafted the RFP and sent it to the consultant candidates

The TAC will meet in late August to review the proposals for the Avian and Bat Mortality Study & Monitoring and will make the final selection of the consultant.

Claudia and Rose were granted a tour of the Hatchet Ridge facility in July and were able to get a firsthand look at the site and the turbines, and gained a better understanding of the technical and operations aspects of the facility.

The turbines have been undergoing operations testing this summer and groups of turbines have been observed rotating on several occasions.

The facility will begin commercial operations sometime between September and the end of October.
